You must possess...

- High school diploma or GED
- Valid driver's license and 5-year driving record with no serious moving violations

You must pass/meet...

- The TABE test requirements for Math and Reading
- Ability to pass a drug test and DOT physical test
- Legal employment status in the United States

You must not have record of...

- DUI
- Reckless or careless driving
- Driving after revocation
- Suspension or cancellation of license
